# **Medford Food Co-op Board of Directors Meeting**

# Monday March 28, 2022

## Call to Order / Introductions

The March 28, 2022 Medford Food Co-op Board of Directors (MFC BOD) meeting was called to order at 5:33 p.m.

### **Owner's Forum**

There were no additional owners present.

### **Previous Meeting Minutes**

- Minutes of the February 28, 2022 MFC BOD regular meeting were submitted. <u>Patty Casebolt moved to accept</u> the minutes as submitted; **Roger Noyes** seconded the motion, which passed unanimously.
- Minutes of the February 28, 2022 MFC BOD Executive Session were submitted. <u>Dan Smith moved to accept the</u> minutes as submitted; Fran Batzer seconded the motion, which passed unanimously.

## **GM MONTHLY REPORT**

### Relevant Financial Information

- February sales were \$439K, a 2% decrease over last February and 91.4% of budget.
- Café Update: Feb sales = \$30.6K, 90% of budget, 7% of sales.
- COGS = \$294K, 92% of budget.
- Operating Expense = \$142K, 90% of budget.
- Net operating income = \$3.6K, 99% of budget.
- Days cash on hand as of 2/28/22 = 81.8
- February On-line Shopping = \$5,082, 36 transactions, \$141 basket size.

#### **Ownership Level Issues**

• In February, MFC added 9 new owners and had 1 owner share redemption.

#### COVID Update

• As of Saturday, 3/12/22, face coverings are no longer required for shoppers, vendors, and employees. We have primarily had positive reactions to this change. A handful of customers have expressed concern about people not wearing face coverings, but they have not been rude to staff.

### Public Events affecting Perception of Co-op in Community

- MFC didn't participate in any public events in February, but plans and invitations are under development for events in April June.
- Sunday, May 1st, 12:00 4:00 pm: Annual Meeting and Good Feed Festival will be held in the store and Café.

### Significant Operational Change and Policy Compliance Updates

• Security cameras: no update.

## **GM MONITORING REPORT**

<u>GM Policy B3: Asset Protection.</u> **GM Carter** reported non-compliance with sub-policy #8 – increased number of daily customer transactions. All submitted reports included detailed interpretation, operational definitions, and supporting data.

**GM Carter** noted that reporting on B3 compliance was moved from an annual review to twice per year, particularly to better track asset protection and sub-policy #8, which has been out of compliance in recent years due to COVID. She expects to see an increase in the number of customers as the pandemic ebbs.

**Peggy Leviton** moved to accept the GM Monitoring Report B3 acknowledging noncompliance; **Matt Dorris** seconded the motion, which passed unanimously.

<u>GM Policy B6: Staff Treatment and Compensation.</u> **GM Carter** reported non-compliance with sub-policy #2 – manager training. All submitted reports included detailed interpretation, operational definitions, and supporting data.

One manager was not able to attend training in the past year. **GM Carter** responded to a question that the coming year looks promising for more manager trainings, both in-person and online.

Matt Dorris moved to accept the GM Monitoring Report B6 acknowledging noncompliance; Dan Smith seconded the motion, which passed unanimously.

- Owner Engagement: Co-Chair Calhoun reported that the Annual Meeting will be held concurrently with the Good Food Festival on May 1, 2022 from 12pm – 4pm, with various events planned in the store, Café and outdoors. The Annual Meeting will be held at 1pm in the Café.
- Nominating: **President Hill** contacted 12 potential candidates; no one had submitted an application by yesterday's deadline. Therefore, the ballot will consist of Sarah Calhoun and Roger Noyes who are running for re-election.
- GM Evaluation: This will be covered in Executive Session.

### **NEW BUSINESS**

## Update Resolution #2014-0001: Capitalization Policy

The update to this resolution is to increase the dollar amounts recommended by the CPA to reflect equipment costs expensed and depreciated. Other than these numbers the content of the resolution remains the same. <u>Matt Dorris</u> moved to accept Resolution #2014-0001 as amended; **Roger Noyes** seconded the motion, which passed unanimously.

### Select Positive Change Recipient for CCF Donation

**GM Carter** described the background of this fund, noting the interest available for the Board to donate was just under \$500. After a brief discussion, <u>Matt Dorris moved to donate MFC's CCF interest to the Pollinator Project Rogue</u> <u>Valley; Roger Noyes seconded the motion, which passed unanimously.</u>

### Authorize Contribution to CCF for Unredeemed Dividends

**GM Carter** and **President Hill** explained that under MFC's revised Bylaws, the Board may select a nonprofit to receive unredeemed patronage dividends. After reaching out to notify as many owners as possible, the amount left after the redemption deadline, totaled with funds leftover from 2016, totaled \$6,205.36. <u>Dan Smith moved to</u> authorize the contribution of unredeemed dividends to MFC's CCF fund; **Patty Casebolt** seconded the motion, which passed unanimously.

### **EXECUTIVE SESSION**

At 6:37 p.m. the Board moved into Executive Session.

### **ADJOURNMENT**

At 8:14 p.m., *Fran Batzer* moved to adjourn the Executive Session; *Sarah Calhoun* seconded the motion, which passed unanimously.
